PRIVACY POLICY

This privacy policy (“Policy”) explains how *Compassion Into Action Network, Direct Outcome Organization*® (“CAN-DO”) uses and protects any information that you give when you use this website.

If we ask you to provide certain information by which you can be identified when using the website, you can be assured that it is protected and will only be used in accordance with this Policy.

CAN-DO will never rent, sell or exchange our donor mailing list with third parties.

We may collect personal and non-personal information that you choose to supply such as the following:

- Personal information, such as contact information including name, mailing address, e-mail address, and phone number
- Session cookies to enhance quick loading of website content navigation
- Cookies that help us recognize when you re-visit our website

How we use Cookies

As with most other Internet sites, our web servers utilize “cookies” to track a user’s activity within our site as well as record the IP address of each visitors to this site. A “cookie” can be either permanent (i.e., it remains on your computer until you delete it) or temporary (i.e., it lasts only until you close your browser). Cookies are used on many websites in order to gather information and enhance your online experience. CAN-DO is not able to gather personally identifiable information through the placement of cookies. If you do not want your information collected through the use of cookies, you can deny or accept the cookie feature using a simple procedure available in most browsers.

Your Secure Donations

In addition to maintaining privacy and security controls over information you share with us, CAN-DO works to securely process your donations. We use technologies and processes such as high-grade encryption, network firewalls, EV-SSL security protocol and other measures to communicate with your browser software. These measures make it extremely difficult for anyone to intercept the credit card information you send to us. When we work with other companies to process credit card transaction, they also use encryption and/or other security measures. CAN-DO does not have direct access or the ability to store donor’s credit card information. Tax-deductible financial contributions to CAN-DO can be made on our secure website, or by mail.

Photos/Videos Confidentiality

Unless noted, all identifying information and photos/video of families, children and elders is confidential. Identifying information includes names, addresses, telephone numbers and descriptive information that would lead to identity.
